**I recognise and want to live the purpose of the Association.**

**The purpose of the Association is to announce to the Universe that:**

**1-** The Most Holy Trinity exists: Father, Son and Holy Spirit, the only true God who has created the Universe.

**2-** Jesus Christ, Son of God and Saviour, incarnated on Earth, a hostile planet, distant from God and close to Lucifer. Here He died and resurrected to destroy Lucifer's work and re-establish an alliance between God and humanity.

**3-** The Redemption worked by the Son of God has extended over the entire Universe, since all humanity must be led back to God through Jesus Christ. For this reason, the whole of humanity will have to choose between Jesus Christ and Lucifer; between the true God and the idols. At the end of times, Jesus will return gloriously to judge the living and the deceased and gather His people around Him.

**4-** Jesus Christ founded His Church on Earth in favour of the whole Universe.

The Church, first cell of the Kingdom of God, is called to announce salvation not only to the humanity of the Earth, but also to that of the whole Universe. In fact, except the humanities who remained faithful to God from the beginning, the other humanities had no knowledge of the work of salvation accomplished by Jesus Christ; they remained in darkness and suffering, oppressed by the action of evil.

**5-** The whole Universe will be recapitulated in Christ according to the plan of God of which St. Paul speaks in his letter to the Ephesians (See Eph 1,8-12).

**6-** St. Michael the Archangel is the Precursor of the second Coming of Christ; he is at the head of the people of God in order to gather them from every part of the Universe and lead them to Jesus Christ, the only Shepherd.

**7-** Three universes exist: the High Universe, the Middle Universe and the Low Universe. Each Universe is inhabited by human beings who are our brothers and sisters, created in the image and likeness of God. They live on planets that are very different from each other. Earth is situated in the Low Universe.

**8-** All those who will have remained faithful, regardless of which planet they belong to, will be taken to the NEW CREATION by Jesus Christ; there, finally liberated from evil, they will forever form one humanity as it should have been from the beginning. "God may be all in all" (1Cor 15:28).

**9-** There are three extraordinary instruments:

The Central Nucleus, the angels and the brothers and sisters of the Universe faithful to God. The extraordinary instruments, particularly the Central Nucleus, accomplish what should have been the task of the Church of the Earth. All those who are called by God, in these times, will gather around these instruments to bear witness to Jesus Christ in the Holy Spirit to the ends of the Universe.

**10-** In the past years, even on Earth a people has formed that has welcomed the plan of God to recapitulate the whole Universe in Christ, putting itself at the disposal of those who want to walk this path. It is a new people, open to the newness of God, seeking to overcome all divisions between Christians and all children of God. It is a people within the People of God, closely united with the extraordinary instruments and all brothers and sisters who, on Earth and in the Universe, believe in the One and Triune God and serve Him faithfully.

**11-** This Association belongs to the Church of Jesus Christ of the Universe, which is formed by the children of God who are present in the whole Universe and who want to:

- offer themselves to God through the Immaculate Heart of Mary for the recapitulation of the whole creation in Jesus Christ;
- live the cosmic Pentecost, that is, submit to God's authority and the laws of the Spirit to unite the whole humanity in the Holy Spirit to form one people;
- reflect the Trinitarian power on humanity and the whole creation;
- await and prepare the glorious coming of Christ to enter with Him the New Creation;
- recognise and proclaim Mary Most Holy as Mother and Queen of the whole Universe and live united with Her Heart;
- announce the Lord's death and proclaim His resurrection, participating actively in the Eucharistic Sacrifice.

**12-** To be committed to live according to the three pillars of the Kingdom of God:

1. the offering one's life to God through the Immaculate Heart of Mary;
2. immaculateness or integrity of life;
3. the universal communion.

**13-** To Recognise and welcome the three extraordinary instruments and live in communion with them, which is a necessary condition for the universal communion.

## **INFORMATION ON PROCESSING OF PERSONAL DATA**

**(Article 13 of the Legislative Decree 196/03 and Article 13 of the EU Reg. 2016/679)**

Pursuant to art. 13 Legislative Decree 196/2003 (hereinafter, the Consolidated Law) "GDPR, General Data Protection Regulation", which regulates the protection of persons and other subjects regarding the processing of personal data; the processing must be based on the principles of correctness, lawfulness and transparency, as well as the protection of your privacy and your rights in relation to the personal data that this non-profit Cultural Association CHURCH OF JESUS CHRIST OF THE UNIVERSE will come into possession in its capacity as Data Controller, in Italy, we are required to provide you with the following information:

### **1. SCOPE OF THE DATA PROCESSING**

The processing is aimed solely for the achievement of the institutional purposes promoted by the association itself within the limits of the statutory provisions and in accordance with the provisions of Legislative Decree n. 196/2003.

### **2. DATA COLLECTION AND PROCESSING**

a. The processing is carried out by means of the operations or set of operations indicated in art. 4 paragraph 1 letter *a*) Consolidated Law: collection, registration, organization, storage, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, cancellation and distribution of data.

b. The operations can be carried out with or without the support of electronic or automated tools.

c. The treatment is carried out by the Data Controller and/or by the persons in charge of the treatment.

### **3. PROVISION OF DATA**

The provision of personal data is strictly necessary for the purposes of carrying out the activities referred to in point 1.

### **4. REFUSAL TO PROVIDE DATA**

Any refusal by the interested party to provide personal data in the case referred to in point 3 makes it impossible to fulfil the activities referred to in point 1.

### **5. COMMUNICATION OF DATA**

Personal data will be made known to the persons in charge of processing and may be communicated for the purposes referred to in point 1 to external collaborators and, in general, to all those subjects to whom the communication is necessary for the correct fulfilment of the purposes indicated in point 1.

### **6. DISCLOSURE OF DATA**

Personal data are not subject to disclosure.

### **7. TRANSFER OF PERSONAL DATA**

Personal data may be transferred to countries of the European Union and to third countries with respect to the European Union within the scope of the purposes referred to in point 1.

### **8. RIGHTS OF THE INTERESTED PARTY**

Art. 7, Consolidated Law, grants the interested party the exercise of specific rights, including that of obtaining from the Data Controller confirmation of the existence or not of personal data and communication of the same in an intelligible form; the interested party has the right to know the origin of the data, the purposes and methods of processing, the logic applied to the processing, the identity of the Data Controller and the subjects to whom the data may be communicated; the interested party also has the right to obtain

the updating, rectification and integration of data, cancellation, transformation into anonymous form or blocking of data processed in violation of the law; the interested party has the right to object, for legitimate reasons, to the processing of data.
